(c) Whether the incumbent is in service or not. The incumbents who have already demitted Office for any

reason will not be entitled for any emoluments. The post will stand abolished.

- 4. Services of Tutor Principal and Tutor Assistant Professor shall be regularized as per provision of the section 8(3), (4) & (6).
- 5. At any point of time, if any fraud document is detected, povincialisation of service of the incumbent will be cancelled.
- 6. Any Tutor Principal, Tutor Asstt. Professor who has already acquired the qualification required as per UGC norms and Service Rules in force on the date of issue of his/her provincialisation order shall be entitled to pay and allowances of a Principal/Asstt. Professor from the date of issue such provincialisation order, provided Tutor Principal/ Tutor Asstt. Professor who acquires such qualification within 5(five) years from the date of issue of his/her provincialisation order shall also be entitled to pay and allowances equivalent to Principal/ Asstt. Professor with effect from the date of acquiring such qualification as per relevant rules for the time being in force.
